1.0 Introduction

Conducting sector reviews is a requirement by Government as recommended in the National Development Plan (NDP) II and provided for in the Agricultural Sector Strategic Plan (ASSP). The review is also in line with MAAIF's continued efforts to strengthen the integration of Result Oriented Management (ROM) and Budgeting.

The Ministry of Agriculture, Animal Industry and Fisheries (MAAIF), in collaboration with the Agricultural Sector Development Partners and Civil Society Organizations conducted the seventh Joint Agricultural Sector Annual Review (JASAR) for the Financial Year (FY) 2016/2017 under the theme "*Accelerating Agricultural Transformation from subsistence to commercial agriculture*". The review workshop was held on the 27th and 28th September 2017 at the Speke Resort Hotel Munyonyo, in Kampala. It was attended by a total of 415 participants including leaders and representatives from Parliament, relevant Ministries and Agencies of Government, Development Partners, Civil Society, Local Governments (LGs), Farmers' Organizations, Private Sector, the Media and staff of MAAIF and its Agencies.

2.0 Objective of the 7th JASAR

The primary objective of the 7th JASAR was to review the performance of the agricultural sector for FY 2016/17 against targets, actions and indicators set out in the Agriculture Sector Budget Framework Paper (BFP) for 2017/18 and the Ministerial Policy Statement (MPS) for the same FY and to propose agriculture sector strategic actions for implementation in the FY 2017/18.

Following sector review guidelines as agreed and required under the CAADP framework, it has more specifically: -

1. Created a platform for stakeholders in the agriculture sector including political leaders, sector institutions, decentralised structures, private sector, civil society and development partners to discuss and review the performance of the agriculture sector, as well as its associated policies and programs;
2. Assessed the trends in overall sector performance based on relevant SDGs, NDP II and ASSP indicators;
3. Assessed the progress of implementation of sector priorities for FY 2016/17 as set out in the Ministerial Policy Statement (MPS) and sector Budget Framework Paper (BFP). This includes challenges and lessons learned;
4. Reviewed sector public financing for FY 2016/17;
5. Assessed progress made towards implementation of the agreed actions for the JASAR 2016 and the cabinet report on Government Annual Performance retreat (GAPR) for FY 2015/ 2016 and another report on the Government Half Annual Performance retreat (GHAPR) for 2016/17;
6. Briefed the stakeholders on the sector priorities as elaborated in the Ministerial Policy Statement/budget for 2016/17 and the Agricultural Sector Strategic Plan (ASSP) 2015/16- 2019/20; and
7. Provided recommendations for increased effectiveness and efficiency in sector performance.

3.0 Review Process

The process involved daily sessions in which presentations of a total of ten papers on various thematic areas and responses to agreed actions from JASAR 2016 were made. At the end of each session, reactions and discussions were made. Furthermore, a presentation on agreed issues and recommendations from the regional JASAR workshop 2017 which was held in Lira was made. This was in addition to a parallel events session organized by the Non-State Actors which presented opportunity for further and deeper analysis of the thematic areas presented earlier. The presentations covered the areas listed below;

1. Response to Agreed Actions from JASAR 2016
2. Agricultural Research and Development;
3. Agricultural Extension Services Delivery;
4. Access to Critical Farm Inputs;
5. Pests, Vectors and Disease Control;
6. Water for Agricultural Production;
7. Markets and Agro Processing
8. Public, Private Producer Partnerships (PPPP)– A Case of Vegetable Oil Development Project (VODP) in Kalangala;
9. Agriculture Sector Performance FY 2016/17;
10. Issues and Recommendations from the Regional JASAR 2017; and
11. CSO perceptions: Pathways for Agricultural Transformation.

Thereafter, participants went to different groups to discuss key issues under different thematic areas. This was followed by a plenary session that involved presentation of identified key issues by selected presenters. This formed the basis for identification of agreed actions that would comprise the *Aide Memoire for the JASAR 2017*. The issues identified are captured below.

4.0 JASAR 2017 Key Issues

The following are the issues that were raised by participants following presentation of papers as well as from the group work.

A. Policy and Planning

4.1 Need to Make JASARs More Inclusive

It was observed that while the last two JASARs 2016 and 2017 had increased participation and capture of regional sector issues, it still lacked targeted focus through comprehensive sector reviews at the Local Government levels.

4.2 Poor Inter Sectoral Coordination

It was also noted that inter sectoral coordination was still sub optimal and required strengthening.

B. Agricultural Extension

4.3 Incomplete Recruitment of Agriculture Extension Workers in DLGs

While most LGs had completed or were in the process of completing approved recruitment of agricultural extension workers, there were still a number of LGs that had not done so to date. It was also reported that MAAIF's request for further additional recruitment outside the current process to reach an acceptable Extension Worker to Farmer ratio had been deferred by MoFPED.

4.4 Inadequate Facilitation of Agriculture Extension Workers

The MAAIF budget included a provision for UGX 49 Bn for procurement of logistics including motor cycles, vehicles and facilitation for the existing and recently recruited agriculture extension workers whose work was severely impeded by their inadequacy.

4.5 Weak Linkage between Agriculture Extension, Research and Farmers

The low adoption rates of new and improved technologies were attributed among others to the weak linkages between Agriculture Extension, Research and Farmers.

C. Research and Development

4.6 Inadequate Dissemination of Information on Proven Research Technologies

It was observed that while NARO reported significant achievement in development and production of new and improved technologies, information about them was still not readily accessible to farmers.

D. Enhancing Access to Critical Farm Inputs

4.8 Inadequate Knowledge of Farmers' Capacities and Interest

It was reported that the mortality rates of inputs distributed to farmers were high due to a number of factors among which included limited knowledge of farmers' capacities and interests. This was manifested in farmers receiving inputs they were not prepared for or even not interested in.

4.9 Delayed Enactment of Bills and Approval of Policies

It was also reported that there were a number of critical policies and bills for agro inputs that were pending or are awaiting approval in Parliament including the National Seed Policy among others.

4.10 Lack of Coherent Agro Input Distribution Strategy and Policy

It was observed that, the current agro Input distribution was being implemented under farmers' organizations or cooperative systems, public sector led interventions like the NAADS/OWC, PPPP type interventions like the VODP, private sector led interventions like Nile Breweries Ltd and Uganda Breweries Ltd (Sorghum) and Mukwano (Sunflower). These interventions were implemented in the absence of a comprehensive agro inputs policy and strategy for guidance.

4.11 Inadequate Capacity for Implementing Regulatory Role

It was also noted that MAAIF capacity for implementing its regulatory role is still inadequate and therefore rendering it unable to efficiently and effectively address coverage, certification, counterfeit products and other salient issues.

4.12 Low Levels of Mechanisation Impeding Increased Production

It was noted that interventions to address increased mechanization and reducing hard labour during production and value addition were still inadequate and registering low impact. One of the reasons attributed to this undesirable outcome was the lack of a National Agriculture Mechanization Policy as well as a Farm Planning Strategy.

4.13 Limited Capacity to Produce Seed and Vegetative Material

It was noted that procurement of inputs under the NAADS /OWC does not promote or enhance local capacity (district/regional level) for production of seed and vegetative materials. For example, citrus farmers in Soroti and Lira were receiving seedlings from the Western region and yet there was local capacity to produce and deliver these seedlings.

E. Pests, Vectors and Disease Control

4.14 Misuse of Agrochemicals by Farmers

Reports indicate that there was prevalent misuse of chemicals, for instance, use of expired chemicals, applying wrong dosages, poor storage and handling among others.

4.15 Supply of Counterfeit Inputs by Agro Input Dealers

Participants reported that there is still persistent presence of fake agro inputs especially seeds and agro chemicals on the market.

4.16 Aflatoxins and Chemical Residues Issues (Both Crops & Animals)

Participants also observed that aflatoxins incidences were mostly due to poor handling, storage and harvesting in addition to poor processing practices. On the other hand, chemical residue incidences were mostly due to ignorance of the withdraw period as well as use of expired chemicals among others.

4.17 Quarantine Enforcement

There were persistent violations of quarantine leading to questions of MAAIF and LG capacity for efficient and effective enforcement. Reasons for this included political interference, weak enforcement capacity, absence or inadequate enforcement infrastructure, abuse of power manifested in intimidation by elected officials, weak laws, poverty and poor professional ethics and moral decay.

F. Water for Agricultural Production (WfAP)

4.18 Inadequate Funding for WfAP

Participants noted that there was inadequate funding to comprehensively address WfAP in the country, especially in the area of access to small scale WfAP interventions and technologies.

4.19 Lack of Guidelines for Management of WfAP Infrastructure

Participants also noted that management of "large" scale WfAP infrastructure was poor which was largely attributed to absence of national guidelines for Water User Associations/Committees and the lack of Operations and Maintenance systems, strategies and plans.

4.20 Weak Inter Agency Coordination

Field visits of WfAP interventions in the Northern Region revealed that challenges in utilization of infrastructure were largely associated with poor inter agency coordination especially describing the relationships between MAAIF, MWE, DLGs and Non- State Actors (NSA).

4.21 Inadequate Equipment and Machinery

It was also observed that services delivered by the heavy equipment unit were largely unknown, inaccessible and also inadequate to address farmers' need across the country.

G. Marketing and Value Addition

4.22 Lack of Concrete Information on Marketing Infrastructure and Value Addition

Participants were of the view that the lack of concrete information on marketing infrastructure and value addition was impeding successful achievement of interventions.

4.23 Limited Involvement of farmers and Farmers' Groups in Management of Sector Infrastructure

Participants were also of the view that underutilization of infrastructure was linked to the limited involvement of farmers and farmers' groups in its management.

4.24 Poor Utilization of Marketing Infrastructure

The issue of poor utilization of existing marketing infrastructure was largely attributed to inadequate capacity building and poor dissemination of Information on appropriate use.

4.25 Limited Information on Food Safety along the Value Chains

Participants also noted that issues of food safety along the value chain were largely due to inadequate training and dissemination of information.

H. Public Private Producer Partnerships (PPPP)

4.26 Inadequate Information Sharing of PPPP Experiences

Participants were largely appreciative of the experiences shared under the PPPP case study of VODP. However, they noted that most of them were unaware of the VODP and other sector PPPP type interventions largely due to inadequate information sharing.

4.27 PPPP Act 2015 Limits Scope for Agriculture Sector

Participants noted that the PPPP Act 2015 currently limits intervention scope to agriculture processing only, which they noted was only one node on the various value chains.

5.0 Recommendations and Agreed Actions

The following are the recommendations arising from the issues that were raised by participants following presentation of papers in the JASAR 2017, from the Regional JASAR held in Lira as well as from the group work in the side or parallel events.

A. Policy and Planning

5.1 Conduct District Local Government Production and Marketing Sector Annual Reviews

It was recommended and agreed that the Department of Agricultural Planning and Development will ensure that future JASARs will feature DLG Production and Marketing Departments sector reviews whose outcome will subsequently feed into and inform the Regional JASAR.

5.2 Strengthen Inter Sectoral Coordination

The Department of Agricultural Planning and Development will review and strengthen existing mechanisms for stronger and more effective inter sectoral coordination.

B. Agricultural Extension Services Delivery

5.3 Complete Recruitment of Agriculture Extension Workers.

The Department of Agricultural Extension and Skills Management will finalize recruitment of all approved posts in the FY 2017/18.

5.4 Provide Facilitation for Agriculture Extension Workers

The Department of Agricultural Extension and Skills Management will procure and judiciously provide logistics and facilitation for DLG extension workers under the UGX 49 Bn provision in the budget for the FY 2017/18.

5.5 Strengthen Linkage between Research, Extension and Farmers

The Department of Agricultural Extension and Skills Management in collaboration with NARO and farmers' organizations will develop or review existing mechanisms for strengthening the nexus or linkage between the three important entities namely research, extension and farmers.

C. Research and Development

5.6 Expedite Operationalization of Technology Information Dissemination Strategy

NARO will review and expedite operationalization of its information dissemination strategy for increased knowledge and awareness on new and improved proven technologies.

D. Enhancing Access to and Utilization of Critical Farm Inputs

5.8 Increase Knowledge on Farmers Capacities and Interests

The NAADS Secretariat in collaboration with the DAES will establish a database of all farmer's and farmers' groups so as to increase knowledge on capacities and interests so as to appropriately target their agro input needs.

5.9 Expedite Approval and Development of Relevant Policies and Strategies

The Director for Crop Resources will expedite approval of the National Seed Policy and in collaboration with the NAADS Secretariat and other key stakeholders.

5.10 Expedite Development of Agro Input Policy and Strategy

The Director for Crop Resources will expedite development and operationalization of a National Agro Input Policy and Strategy.

5.11 Increase MAAIF Capacity for Implementing Regulatory Role

The Director for Crop Resources, Fisheries Resources and Animal Resources will initiate mechanisms and interventions designed to increase MAAIF capacity for executing its regulatory role.

5.12 Develop and Operationalize National Agricultural Mechanization Policy and Farm Planning Strategy

The Commissioner Agriculture Infrastructure, Mechanization and Water for Agriculture Production will develop and operationalize national agricultural mechanization policy and farm planning strategy.

5.13 Promote and Enhance Local Capacity for Input Production

The NAADS Secretariat will promote and enhance local production through procurement of agro inputs within the agro ecological zones.

E. Water for Agricultural Production (WfAP)

5.14 Advocate for Introduction and Institutionalization of WfAP Conditional Grants

The Commissioner for Agriculture Infrastructure, Mechanization and Water for Agricultural Production (CAIMWfAP) will in collaboration with all Directors as well as NSA initiate sustained lobbying for institutionalization of a dedicated DLG WfAP grant to specifically address small scale WfAP among others.

5.15 Develop and Operationalize National Guidelines for Management of WfAP

Infrastructure

The Commissioner for Agricultural Infrastructure, Mechanization and Water for Agricultural Production (CAIMWfAP) will: -

1. Review or develop national guidelines for Water User Associations/Committees for management of WfAP Infrastructure; and
2. Develop and operationalize Operations and Maintenance (O&M) systems and plans.

5.16 Strengthen Inter Agency Coordination

The Commissioner for Agricultural Infrastructure, Mechanization and Water for Agricultural Production (CAIMWfAP) will: -

1. Form Technical Working Groups that will include State and Non State Actors on WfAP with specific Terms of Reference; and
2. Initiate and sustain Inter Sectoral planning and monitoring of interventions, projects as well as cause the holding of regular meetings.

5.17 Procure Equipment and Machinery

The Commissioner for Agricultural Infrastructure, Mechanization and Water for Agricultural Production (CAIMWfAP) will seek or and mobilize funding for procurement of additional equipment and heavy machinery.

F. Pests, Vectors and Disease Control

5.18 Reduce Misuse of Agrochemicals

The Department of Crop Protection and Department of Livestock Health will in collaboration with the DAES: -

1. Develop and implement intensive sensitization on proper use of agrochemicals;
2. Strengthen its departmental regulatory role; and
3. Ensure close supervision and monitoring of agro input dealers.

5.19 Address Aflatoxin and Chemical Residue Issues

1. The Department of Crop Production will lead implementation of interventions (sensitization/training, research) targeting increased awareness on use of proper Post-harvest Handling technologies;
2. The Department of Crop Inspection and Certification, and Department of Livestock Health will lead enforcement of standards, increase awareness on withdraw periods, adhering to proper dosages, institute routine surveillance of products on the market and review residue monitoring plans for various commodities.

5.20 Strengthen Quarantine Enforcement

The Directorates of; Fisheries Resources, Crop and Animal Resources will: -

1. Review laws and penalties;
2. Increase awareness on relevant laws using various media; and
3. Strengthen enforcement with assistance of the Agriculture Police.

5.21 Increase Capacity for Regulation, Enforcement and Routine Surveillance of Products on Market

The Department of Crop Inspection, and Certification, Directorate of Fisheries and Department of Livestock Health will ensure increased capacity for regulation, enforcement and will institute measures for routine surveillance of agro products on the markets.

G. Marketing and Value Addition

5.22 Establish Baseline of Existing Primary Processing and Value Addition Infrastructure

The Department of Agriculture Investments and Enterprise Development will conduct an inventory of existing primary processing, storage, value addition and marketing infrastructure and their status;

5.23 Empower Farmer Groups/Private Sector

The Department of Agriculture Investments and Enterprise Development will lead interventions aimed at empowering farmers and farmers groups for them to co-own or take over management of marketing, value addition and storage infrastructure, all Directorates must have outputs geared towards farmer/private sector empowerment.

5.24 Conduct Capacity Building and Dissemination of Information on Appropriate Use and Utilization of Infrastructure

All Directorates lead by the Department of Agriculture Investments and Enterprise Development will conduct capacity building as well as raise awareness on appropriate use and utilization of infrastructure through dissemination of relevant information.

5.24 Promote Food Safety along the Value Chains

The Directorate of Animal Resources, Directorate of Fisheries and Department of Crop Production and specifically the Food Security and Nutrition Unit will conduct training and disseminate information on food safety and nutrition along the value chain.

H. Public Private Producer Partnerships (PPPP)

5.25 Disseminate Information on VODP Model and Experiences

The Department of Crop Production will disseminate information on VODP model and experiences among stakeholders.

5.26 Lobby MoFPED on Review of Scope Provision in the PPPP Act 2015

The Department of Crop Production will engage with MoFPED to review scope provided for the law to address other nodes along the value chain in addition to agro processing.
