1.0 INTRODUCTION

The Joint Agricultural Sector Annual Review (JASAR) is an accountability event agreed upon by the Africa Union (AU) and provided for in the CAADP, NDP II and ASSP. The Ministry has been organizing Joint Agricultural Sector Annual Reviews (JASARs) since 2011. In collaboration with Development partners, MAAIF held the 8th JASAR at Speke Resort Munyonyo from the 28th -29th August, 2018. The theme for this JASAR was "Building resilience to climate change effects to enhance agricultural productivity". The workshop was attended by a total of 266 participants that consisted of representatives from Parliament, relevant Ministries and Agencies of Government, Development Partners, Civil Society Organizations, Local Governments (LGs), Farmers' Organizations, Private Sector, the Media and staff of MAAIF and its Agencies (annex I).

2.0 Objective of the 8th JASAR

2.1 The primary objects of the JASAR were;

- To review the performance of the agriculture sector for FY 2017/18 against targets, actions and indicators set out in the Ministerial Policy Statement (MPS) for FY 2017/18
- To make proposals for moving the agriculture sector forward.

2.2 The specific objectives of JASAR 2018 were to:

- Create a platform for stakeholders in the agriculture sector to review the sector performance
- Assess the progress of implementation of sector priorities for FY 2017/18 as set out in the MPS and sector BFP including challenges & lessons learned.
- Assess the trends in overall sector performance based on relevant SDGs, the NDPs and the ASSP indicators
- Asses sector public financing for FY 2017/18.
- Assess progress made towards the agreed actions for the JASAR 2017
- Appraise the stakeholders on the sector priorities for 2018/19 and identify priorities for FY 2019/20

Provide recommendations for increased effectiveness and efficiency in sector performance The key output from the JASAR was the aide memoire which included a record of agreed actions/ undertakings to be implemented in the 2019-2020 financial year.

To achieve the above objectives, there were presentations made from different speakers, followed by parallel sessional discussions in groups and finally, plenary to generate agreed actions.

3.0 Review Process

The process climaxed in a 2 day non residential workshop in which nine (9) presentations including one on implementation status of the JASAR 2017 agreed actions were made. At the end of each session there were reactions and discussions. Furthermore, a presentation on agreed issues and recommendations from the regional JASAR workshop 2018 which was held in Mbale was made. The presentations covered the areas listed below;

- An overview of JASAR 2018
- Overview of the Sector performance for FY 2017/1
- Performance on agreed actions for JASAR 2017
- Drivers of Agricultural Productivity Growth in Uganda
- Forecast-Future of Food Security in Uganda
- Issues and recommendations from the regional JASAR workshop
- Building resilience to climate change effects to enhance agricultural productivity
- Improving agricultural sector competitiveness and unlocking opportunities
- Multi-sectoral Approach to JASAR-CAADP Requirement

On day 2, participants went to 6 different groups to discuss the thematic areas in parallel sessions. These were:

- Group I. Productivity:
- Group 2. Marketing:
- Group 3. Agricultural Infrastructure:
- Group 4. Agriculture Finance:
- Group 5. Knowledge:
- Group 6. Regulation and certification

This was followed by a plenary session that involved presentation of identified key issues by selected presenters. This formed the basis for identification of agreed actions that would comprise the Aide Memoire for the JASAR 2018. The issues identified are captured below.

The review workshop was officially opened by the sector Minister, Hon. Vincent Bamulangaki Sempijja who thanked participants for coming for the meeting. He gave an overall overview of the agricultural sector with key challenges and priorities for 2019/2020. Prominent among his highlights, he emphasized the conducting of JASAR as a mandatory obligation under CAADP and elaborated the importance of JASAR and the plans for development of agriculture. He finally, thanked all stakeholders for the work done so far and asked all stakeholders to work with private sector because it is key for success. Finally, the Minister declared the workshop open.

It was closed by the Hon. Minster of State for Agriculture on 29th August 2018. He thanked all categories of participants for honoring the invitation and participating in JASAR 2018. He accordingly, informed members of the mission of MAAIF as to transform agriculture from subsistence to commercial and said the review is in furtherance of the mission. He noted that extensive discussions of presentations on challenges in agriculture had been done and proposed solutions identified. He further informed members that the ministry will continue to strengthen research, ensure quality inputs, extension to control pests, support irrigation, agro-processing, develop agriculture through farmer organization and cooperatives by consolidating achievements.

4.0 JASAR 2018 Key Issues

The following are the issues that were raised by participants during discussions in the plenary and parallel sessions:

A. Agricultural Productivity

- 4.1 Limited resources to facilitate service delivery at the district local governments.
- 4.2 Limited knowledge and awareness about the National Organic Fertilizer Policy Lack of awareness on NAO Policy
- 4.3 Weak research-farmer Linkage leading to low adoption of generated technologies.
- 4.4 Limited extension and advisory service to the farmers
- 4.5 Poor Soil Management and lack of soil fertility analysis
- 4.6 Limited information on the availability of the improved technologies
- 4.7 Lack of guidance by extension workers on what to grow and in which quantities

B. Marketing:

- 4.8 Inadequate market information and agricultural data.
- 4.9 Lack of organized farmer groups affects marketing and procurement of quality farm inputs.
- 4.10 Poor coordination among all stakeholders and key Government MDAs especially on disease control, marketing and promotional activities
- 4.11 Limited value addition and branding of Uganda's top Agricultural Commodities leading to loss of product identity and lower market prices
- 4.12 Unstructured markets: More so are informal markets where neighboring countries buy directly from farmers causing price distortions
- 4.13 Poor produce storage facility around the country

C. Agriculture Finance

- 4.12 There is no agriculture financing policy and strategy to guide agricultural financing
- 4.13 The Agriculture Credit Facility is not accessible to most of the agricultural value chain actors
- 4.14 The establishment of the Agriculture Bank is long overdue

D. Knowledge:

- 4.15 Lack of practical agriculture training
- 4.16 Neglect of indigenous knowledge especially on preservation of crop/animal varieties
- 4.17 No user friendly agricultural messages: Most information is in hard forms and not easily accessible by the youths

E. Regulation and certification

- 4.18 Poor Certification and Inspection Infrastructure
- 4.19 Low capacity levels in inspection (in terms of manpower, transportation, and facilitation)
- 4.20 Poor diseases surveillance, control and management
- 4.21 Weak capacity for effective enforcement and regulation of the sector.
- F. Agriculture infrastructure
- 4.22 Weak Producer organizations, as a core for sustainable agric. Infrastructure
- 4.23 Weak/Lack of infrastructure development, operation and maintenance capacity at all
- levels (National, Regional, District and community)
- 4.24 Limited funding for Districts for agricultural infrastructure (water for agricultural production, mechanization and storage)
- 4.25 Lak of regional technical support offices for water for agricultural production and mechanization
- 4.26 Lack of appropriate economic models for infrastructure investment

G. Policy , planning and support services

- 4.27 There are many pending policies, Bills, and Regulations
- 4.28 Some districts lack Ordinances and bylaws to enable them carry out enforcement of regulations
- 4.29 Inconsistence in policy implementation resulting from weak multi-sectoral approach to policy implementation
- 4.30 Lack of effective Private Sector Engagement in policy formulation and implementation.
- 4.31 No Gender Strategy: The current National Gender Policy is not formally mainstreamed in Agriculture
- 4.32 There is increasing dependence syndrome by farmers on freely distributed farm inputs by government
- 4.33 No transparent criteria for free seed distribution causing targeting challenges
- 4.34 Updated Agricultural Statistics is not readily available
- 4.35 Farmers and prospective agricultural investors lack guidance on the profitability of farming in Uganda
