Members of the Press Present, Greetings to You All!

The Ministry of Agriculture, Animal Industry and Fisheries has a mission to transform the sector from subsistence agriculture to commercial agriculture and specifically under the National Development Plan III is the Program Technical Coordinator for the Agro Industrialization Program of the Government of Uganda.

The Agro Industrialization Program has 6 key objectives that include; *(i)* Increasing agricultural Production and Productivity *(ii)* Improving Post Harvest Handling and storage of agricultural products *(iii)* Increasing Agro-processing and value addition *(iv)* Increasing Market Access and Competitiveness of agricultural products in domestic and international markets *(v)* Increasing mobilization, access and utilization of agriculture finance and *(vi)* Strengthening institutional coordination for improved service delivery.

In line with Government's program to move more people into the money economy through increased agricultural production and productivity, the discussion on the efficacy of agrochemicals has taken centre stage in the public domain over the past few months.

Whereas application of agrochemicals in agriculture has several benefits which range from yield increase of agricultural crops and soil fertility to pest management, crop protection and increased productivity in the livestock subsector, over the past decade, there have been growing concerns on the low levels of efficacy of some of the available agrochemicals and acaricides in Uganda.

This prompts the question - what is the problem? Is the problem the quality of drugs because of weak government regulation? (are fake drugs being dumped onto our market?). Is it poor application by farmers? or it's an issue of disease resistance against the available drugs? Or is it a combination of some or all the above? We need to know and respond appropriately in a precise and concise manner.

Based on this background and in response to the frequent outcry of farmers and other farming stake-holders regarding the quality and efficacy

of animal and crop drugs and other inputs in the control and fight against diseases; I have decided, after serious consideration and consultation, to appoint a committee of eminent persons with reasonable expertise (professionals and practitioners) in the crop and animal husbandries to assess the persistence of this problem, including the prevalent drivers and propose viable interventions towards the issues of quality and the regulatory frameworks of agro chemicals& agro-inputs. This team will be supported by a Secretariat at the Ministry who will include technical officers at the Ministry and relevant Agencies

The following are the specific terms of reference for the committee:

- a) Study and profile the various agrochemicals, acaricides and inputs and their various sources that are available on the market in Uganda.
- b) Study and profile the supply chain of agrochemicals, acaricides and inputs in Uganda with a view to establish existing gaps and loopholes in policy, regulatory frameworks and usage.
- c) Study and inquire into the forms of complaints and their probable root causes regarding the quality of agrochemicals, acaricides and inputs from the farmers and other stakeholders in the entire value chain.
- d) Study and review the appropriateness of the current Government policy, institutional mandates and regulatory frameworks for agrochemicals, acaricides and inputs
- e) Make recommendations on the necessary reforms that Government needs to undertake in addressing the identified gaps in a sustainable manner.
- f) Submitting the final report within 90 days; during this period of Lockdown, they will do desk research and review available relevant literature

On receipt of the final report, the Ministry of Agriculture, Animal Industry and Fisheries (MAAIF) shall formulate a government white paper with clear

policy and regulatory reforms that will help to address the identified gaps for Cabinet discussion and consideration.

Interventions that don't utilize research but are only informed by anecdotal sources, people's feelings, opinions and emotions, tend to be ineffective. As such, we want to understand the actual problem and respond with the appropriate policy therapy.

In the same breath, I appeal to the many farmers, exporters, processors and all sector stakeholders who have been reaching out to me since my appointment on these problems of animal and crop diseases that seem to be resistant to the available drugs, to be patient and allow this study to be conducted such that we undertake policy and regulatory reforms in the sector that are evidence based.

This committee will help us to understand the actual problem, its magnitude and thus make relevant therapeutic policy recommendations. These will be discussed by Cabinet and thereafter adoption of the most effective ones.

Finally, to the farming community and private sector actors, I make this commitment to you – that once the lockdown has been lifted, I together with my colleagues will lead a team of experts from the Ministry and our Agencies in conducting sub-regional farming dialogues with you. During these farming dialogues, we shall develop farming profiles for each of the sub-regions and also listen to your constraints along the respective value chains including the rationale for investment in agriculture. These will guide our interventions, to among other things, ultimately attract more local, regional and international investment to the sector. My pledge to you is that under my leadership, MAAIF will design and implement interventions based on evidence of clearly understood constraints and respective sub-regional farming profiles.
